Each candidate is requested to provide the Registrar with a personal statement of **no more than two hundred and fifty (250) words** to be made available to prospective voters. In addition to this statement, each candidate is requested to also provide the Registrar with the following information:

- i. The candidate's academic and honorary degrees;
- ii. The candidate's current occupation;
- iii. The candidate's current and past academic, societal, governmental, or commercial offices held;
- iv. The candidate's current professional or business interests; and
- v. The candidate's list of publications (if any).

**Enrolment Services must receive completed nominations, personal statements, and the above supplemental information by 4 pm on Wednesday 16 July 2025.**

The receipt of all nominations will be confirmed via email within 24 hours of the close of nominations. If you do not receive such confirmation you must contact UBC Elections at [elections.information@ubc.ca](mailto:elections.information@ubc.ca) within 24 hours or your nomination will be nullified.

Completed forms should be scanned and emailed to UBC Elections at [elections.information@ubc.ca](mailto:elections.information@ubc.ca) along with the accompanying personal statement and supplemental information in order for it to be made available to voters. Deadlines and word limits are strictly enforced. Requests for changes to previously submitted supplemental information after the deadline will not be accepted.

If required, voting is expected to occur in August 2025.
